



ACCOUNTING POLICIES & NOTES ON ACCOUNTS

We have audited the attached balance sheet of **Bhasha Research and Publication Centre** as at **31st March 2021** and also the Income & Expenditure account for the year ended on that date.

These financial statements are the responsibility of the Trust's Management i.e. the Board of Trustees. Our responsibility is to express an opinion or comments in the form of report on these financial statements based on our Audit.

We have conducted our audit in accordance with the auditing standards generally accepted in India & on the basis of such vouching & verification procedures as we consider appropriate. Our audit includes examining on test check basis evidence supporting the amounts & disclosures in the financial statements.

We believe that our audit provides a reasonable basis for our opinion or comments given in the attached report.

A. Accounting Policies: -

- 1) The trust generally follows mercantile system of accounting & recognizes income & expenditure on accrual basis.
The accountings of the trust are prepared on Historical cost convention & on Going Concern basis.
- 2) Fixed Assets of the trust i.e. furniture & fixtures, Books, Computer, Medical Equipment, Building, office equipment as per AS-10 are stated at cost of acquisition. Costs comprise the purchase price and any other costs if attributable.
- 3) Depreciation as per AS-6 on Fixed Assets of the trust is provided on written down value method at the rates prescribed in Appendix I (Rule 5) of the Income Tax Act.
- 4) Inventories:
Inventories (Stock of Food Grains and Books) as per AS-2 are valued at cost or market value whichever is lower.
- 5) Investments: Investment (Bank Fixed deposits) as per AS-13 is stated at its cost.
- 6) Taxation: No provision for taxation is the considered necessary in view of the eligibility of the trust for deduction u/s 11 of the Income Tax Act, 1961.
- 7) Donations Received in Foreign currency:
Donations received in foreign currencies are recorded at the exchange rates prevailing on the date of receipt of donation.
- 8) Grants:-
Grants are credited to Income & Expenditure A/c. & the balances remaining therein if any, are transferred to respective earmarked fund in the balance sheet.

9) Deferred Tax Asset or Liabilities:

The trust has substantial unabsorbed depreciation and carried forward losses as per Income Tax Act (on the basis of Income Tax returns) resulting in net deferred tax assets which are not recognized in the Income & Expenditure account as a matter of prudence and in accordance with Accounting Standard – 22 issued by the Institute of Chartered Accountants of India.

10) Revenue Recognition:

Revenue as per AS-9, in respect of other income is recognized only when no significant uncertainty as to its determination or realization exists.

11) Other Accounting Policies: These are consistent with generally accepted accounting principles in India & the accounting standards issued by the Institute of Chartered Accountants of India.

B. Notes on Accounts:-

- 1) In the opinion of the trustees the value of realization of current assets & advances in the ordinary course of activity of the trust will not be less than the amount at which they are stated in the Balance-Sheet.
- 2) Shortfall if any in earmarked Grants & Donations is recouped out of funds of other earmarked Grants & Donations of the trust. Balances of earmarked Grants & Donations (Annexure –A & B) as of **31.03.21** represent the net balances of grants & donations after adjustments of inter Grant & Donation balances of the trust as stated above.
